At its last meeting September 15, 2010 the University Budget Committee (UBC) reviewed the recent request by the Craig School of Business for a three-year suspension of the Masters in Accountancy program. The UBC noted that it was an unfortunate situation that necessitated the request and acknowledged the College's strength in doing so in light of the fact that students will be adversely impacted.

The decision to suspend the program will require the Craig School of Business to provide those students with appropriate guidance and support whether they choose to change their academic focus or seek to complete their degree at another institution.


