- A. Chair Botwin will give an update on the Assistive

Friendly Amendment:

Under General Policy, change the sentence following the first paragraph that begins “Promotion shall be accompanied...” to “Promotion shall be accompanied by salary advancement as stated in the Collective Bargaining Agreement.”

MSC to forward the Policy on Promotion (APM 327) to the Academic Senate for its approval.
