A meeting of the Academic Senate was called to order by Chair Botwin at 4:05 p.m. in the University Center, Room #200.

1. Minutes. MSC to approve the Minutes of 9/10/07.

3. Communications and Announcements.
  - A. Chair Botwin introduced and welcomed the new University-Wide Senator, Paula Sanmartin (Arts & Humanities).
  - B. Vice Chair Caldwell shared information regarding the new Alcohol Safety Council Faculty Pledge Program.
  - C. William Fasse, Associate Provost, Interim shared information regarding the Voluntary System of Accountability (VSA) for colleges and universities. The California State University system is participating in the VSA initiative. This is in response to developing standards for accountability in higher education at the federal level (i.e. the Spelling's report on accountability in higher education). A template was presented that will be used by all institutions subscribing to the VSA. Dr. Fasse answered several questions from the body regarding the intent and implementation of VSA. Dr. Fasse presented this as a pro-active measure using currently published information as a tool. Discussion focused on the

potential uses and misuses of the data presented in the VSA and its implications for our campus.
