4. Campus Parking Policy.

M. Babick distributed a handout that provided a summary of visitor parking during the fall semester. C. Edmonson related her recent experience dealing with campus visitors seeking a parking spot; it was noted that all information related to parking is in English and that perhaps Spanish information could also be provided. A wide-ranging discussion of various issues related to parking ensued.

5. Update on Campus Construction Projects.

G. Wilson updated the committee on various ongoing projects:

- a. The initial bids for the swimming complex were too high; rebids have been requested and will be opened in mid-April.

- b. HVAC repairs to the Ag and IT buildings are ongoing.
- c. The remodel of nursing labs in the "H" wing of McLane will take place over the summer.
- d. The University High School project is now about a month behind schedule due to weather problems and delays in receiving the steel beams. It will probably be completed by the end of the year.
- e. An initial project meeting for the new Gibson Farm Market building will take place later this month.
- f. An initial project meeting has taken place regarding the proposed hotel in the Campus Pointe area. It was noted that the size of the proposed hotel has been reduced and that parking issues need to be discussed.
- g. There was discussion regarding the future of the University Center building and the need for a facelift if the building is to continue in use for the near future.
- h. Over the next several months, a number of campus offices will be moving as part of the final re-adjustments from the library project.
