## Fall Semester 2019 Tuition Fee Payment Plan for Residents Terms and Provisions

The CSU makes every effort to keep student costs to a minimum. Fees listed in published schedules or student accounts may need to be increased when public funding is inadequate. Therefore, CSU must reserve the right, even after fees are initially charged or initial fee payments are made, to increase or modify any listed fees. All listed fees, other than mandatory systemwide fees, are subject to change without notice, until the date when instruction for a particular semester or quarter has begun. All CSU listed fees should be regarded as **estimates** that are subject to change upon approval by the Board of Trustees, the Chancellor, or the Presidents, as appropriate. Changes in mandatory systemwide fees will be made in accordance with the requirements of the Working Families Student Fee Transparency and Accountability Act (Sections 66028 - 66028.6 of the Education Code).

California State University, Fresno has instituted a Tuition Fee Payment Plan. This optional payment plan enables resident students to defer a portion of their tuition fee payment (course fees, professional program fees, non-resident tuition fee, and all other fees are not deferrable).

The Tuition Fee Payment Plan is subject to the following terms and provisions:

1. Students who apply for financial aid or obtain a waiver or deferral of tuition and other fees, are not eligible to participate since payment is waived/deferred through that process.
2. This Tuition Fee Payment Plan defers a portion of the tuition fee only; it does not defer Course Fees, Professional Program Fees, Non-Resident Tuition Fees, Student Involvement & Representation Fee, and all other fees.
3. A \$33.00 non-refundable administrative fee is included to cover costs associated with the Tuition Fee Payment Plan.
4. The Tuition Fee Payment Plan Contract must be signed and remitted with the first installment payment (refer to the Payment Plan Schedule above for fee rates). Course Fees, Professional Program Fees, and Non-Resident Tuition Fees, Student involvement & Representation Fee must also be remitted when applicable.
5. The first installment and contract must be received no later than 3:30 p.m. on July 31, 2019.
  - Payments and contracts not received by July 31, 2019, may result in the disenrollment of all classes, full or prorated fees owed and forfeiture of all tuition and other fees paid to date.
6. The second Installment payment is due by 5:00 p.m. on September 11, 2019.
  - Payments not received by the installment due dates, may result in the disenrollment of classes, full or prorated fees owed and forfeiture of all tuition and other fees paid to date.
