No refunds are allowed on or after Thursday, October 29, 2015.

Refunds are calculated on a calendar day basis from the first day of instruction to the last day of exams, excluding breaks in instruction of five (5) consecutive days or more. Refunds are allowed to the 60th percentile of the semester. For Fall 2015, first day of instruction is August 25, 2015, and the last day of exams is December 17, 2015. Each day within the semester is 1/110 of the semester.

Refund amounts have been rounded off to the nearest whole dollar on this schedule. Actual refunds are calculated using dollars and cents and your actual refund may vary slightly from what is shown on this schedule.
