You must read and agree to the following Student Statement of Financial Responsibility in its entirety.

Student Statement of Financial Responsibility

- * First day of instruction is defined as the date submitted by the Provost and approved by the Chancellor's Office.
- 1. I agree by registering for a course or courses, attending or not, I am incurring a financial liability, and I understand the amount due must be paid by the established payment deadline. Failure to pay the amount due may subject me to denial of services and/or being sent to collections and credit reporting.
- 2. I understand Fresno State will periodically send courtesy emails to my official University Fresno State email account, informing me that my electronic bill is available. Not viewing does not relieve me of the responsibility to pay the amount due.
- 3. I understand *I am consenting to receive my annual 1098T statement electronically via MyFresnoState*. It is my responsibility to provide a Social Security Number or Individual Taxpayer Identification Number to the University. Failure to comply with this requirement may result in a \$50 penalty, assessed by the IRS under Section 6723.
- 4. I understand for *any enrollment*, financial aid, scholarships and fee waivers awarded to me may be deducted from the amount due to the University. However, if financial aid does not pay my *amount due*, *or if my financial aid award is reversed*, *I understand it is my responsibility to pay any remaining amount due by the established payment deadline*.
- 5. I understand I may be dis-enrolled from all courses if:
 - (a) I fail to pay the amount due by the payment deadline; and if
 - (b) I do not have a fee deferment on my student account
- 6. I agree to read, and adhere to the University's Payment Policy and Deadline Dates. *If I drop courses on or after the first day of instruction**, I may owe full or prorated amounts.
- 7. Cancellation of Registration

A student who registers for courses and who drops all courses for **the period prior to the first day of instruction***, for that term shall be entitled to an adjustment of registration of all tuition and mandatory fees paid.

8. Adjustment of Registration

According to University procedures, a student who, officially drops courses within the first 10 days of instruction*, shall be entitled to an adjustment of tuition and mandatory fees less an administrative fee of \$5.

- 9. Withdrawals
 - A. For state-supported semesters, and non-standard terms or courses of four (4) weeks or more:

A student who, on or after the first day of instruction* and up to a date that includes the sixty percent point in the academic period, either:

(a) drops all of the courses in which the student enrolled prior to the end of the University-designated drop period, or

- (b) officially withdraws for the enrollment period in accordance with University procedures, shall be entitled to an adjustment of tuition and mandatory fees on the basis of the proportion represented by the number of days in the academic period, excluding breaks of five (5) days or more.
- B. A student who officially withdraws from the University after the sixty percent point in the academic period, or fails to drop courses prior to the end of the University drop period, or fails to officially withdraw from the University, shall not be entitled to any adjustment of tuition or mandatory fees.
- C. For state-supported, non-standard terms or courses of less than four (4) weeks: a student registered for a state-supported, academic period or any course of less than four (4) weeks in duration shall not be entitled to any adjustment of tuition and mandatory fees if the student fails to either drop the courses or cancel registration *prior to the first day of instruction*.
- 10. I understand it is my responsibility to read and adhere to *Continuing and Global Education policies* regarding payment, add/drop, procedures, and deadlines <u>Registration Information</u>
- 11. The CSU makes every effort to keep student costs to a minimum. Fees listed in published schedules or student accounts may need to be increased when public funding is inadequate. Therefore, CSU must reserve the right, even after fees are initially charged or initial fee payments are made, to increase or modify any listed fees. All listed fees, other than mandatory systemwide fees, are subject to change without notice, until the date when instruction for a particular semester or quarter has begun. All CSU listed fees should be regarded as **estimates** that are subject to change upon approval by the Board of Trustees, the Chancellor, or the Presidents, as appropriate. Changes in mandatory systemwide fees will be made in accordance with the requirements of the Working Families Student Fee Transparency and Accountability Act (Sections 66028 66028.6 of the Education Code).
