California State University, Fresno has instituted a Tuition Fee Payment Plan with guidelines issued by the CSU Chancellor's Office. This optional plan enables students to defer a portion of their tuition fee (course fees, professional program fees, non-resident tuition fee, and all other fees are not deferrable).

1. Students who apply for financial aid or obtain a waiver or deferral of tuition and other fees, are not eligible to participate since payment is waived/deferred through that process.
2. This Tuition Fee Payment Plan defers a portion of the tuition fee only; it does not defer Course Fees, Professional Program Fees, Non-Resident Tuition Fees, Student Involvement & Representation Fee, and all other fees.
3. A \$33.00 non-refundable administrative fee is included to cover costs associated with the Tuition Fee Payment Plan.
4. The Tuition Fee Payment Plan Contract must be signed and remitted with the first installment payment (refer to the Payment Plan Schedule above for fee rates). Course Fees, Professional Program Fees, and Non-Resident Tuition Fees, Student involvement & Representation Fee must also be remitted when applicable.
5. Payments and contracts must be received no later than 5:00 p.m. on Thursday, December 7, 2017.
6. Payments and contracts not received by December 7, 2017, will result in the disenrollment of all classes.
7. Students have until Census date (February 12, 2018) to opt out on the \$2.00 Student Involvement & Representation Fee.
8. The second Installment payment is due by 5:00 p.m. on February 12, 2018.
9. Payments not received by the installment due dates, may result in the disenrollment of classes and forfeiture of all tuition and other fees paid to date.
