General Assignment:

The External Relations Coordinator serves as the office manager for the departments of Communications, Marketing, New Media and Video Production. This position will report to the Assistant Athletics Director for External Relations. The position requires the incumbent to work effectively with staff to ensure appropriate office assignments are prepared. This position is responsible for coordination of all donation requests, student-athlete appearance requests and the representative with the Student-Athlete Advisory Committee. This position fulfills budget requests and payments, and oversees conference championships and press credentials. This position provides office oversight and maintains historical archives and department policies. This position works with other external department staff to deliver a consistent message to all parties.

- Bachelor's Degree from an accredited four-year college or university in a related field
- One year full-time equivalent experience in collegiate or professional sports setting
