General Assignment:

Under direction of the Director of Sports Medicine and Staff Athletic Trainers, the Athletic Trainer Graduate Intern learns and practices a number of support functions leading to success in the overall operation of the Athletic Training Program. Athletic Training experiences include, but are not limited to: home and away event coverage, sport team coverage and travel, treatment and rehabilitation of student-athletes, necessary medical referrals, and determination of athletes’ ability to compete. The graduate intern will gain experience in the supervision of athletic training students in an accredited athletic training program in all aspects of therapeutic exercises and modalities and athletic training room operations. Successful applicants must pursue a graduate program in conjunction with this internship. (Deadline to enroll in CSU, Fresno Graduate Program for 2015 fall semester is April 1, 2015.)

Required Education, Experience, Knowledge, Skills and Abilities:

- Bachelor’s degree from an accredited four-year institution by July 1, 2015
- Possession of a National Athletic Training Certification (NATA) by July 1, 2015 (If a successful candidate does not obtain the NATA certificate by the required date, the Director of Athletic Training may grant an accommodation or waiver.)
- Experience in athletic training in a variety of sports
- Demonstrated ability to relate effectively with individuals from diverse ethnic, cultural and socioeconomic backgrounds and project a professional attitude
- Ability to:
 - learn the National Collegiate Athletic Association rules and regulations
 - support the gender goals of the university
 - maintain a courteous and professional attitude in stressful situations
- A work history of regular attendance and positive performance evaluations

Application Requirements:

A University [Application for Athletic Corporation Positions](#), a resume, and a list of three professional references, including telephone numbers, are required. A cover letter that addresses your qualifications for the position is required.

Thank you for your interest in a non-faculty position at Athletic Corporation. Please note that with the exception of designated sensitive positions, applicants selected for an interview are required to respond within 72 hours to an important question regarding a conviction history. Failure to respond within this timeframe will subject you to elimination for further consideration. As an Athletic Corporation applicant, you are responsible for checking and responding to this email within the required deadline.

Background investigations will be conducted, as required, depending upon the job requirements of a position. These could include, but are not limited to, processing of fingerprints through the Department of Justice and degree and license verifications. An offer of employment may or may not be extended based upon the results of these verifications.
