Equipment Operations Manager **Athletic Corporation – Vacancy #A412**

Compensation:

\$3,750 - \$4,000 per month, depending on experience and qualifications. This position includes full benefits. This is a full-time, exempt position. Athletic Corporation employees are at-will.

Overview:

Reporting to the Senior Associate Athletic Director/Business and under the general supervision of the Sport Supervisor and Head Coach, the incumbent will be responsible for all of the daily equipment needs for the assigned sports in a Division 1 collegiate environment. This position has a flexible work schedule, some evenings, weekends and holidays are required. Travel with assigned sports team will be required.

Essential Functions:

- Manage practice for the coaching staff as it pertains to equipment needs.
- Make repairs to equipment that may be broken or damaged during practice and games.
- Supervise and train team of approximately 7-20 student managers. Hire, oversee and assign responsibilities, exercise professional discretion, independent judgment and the ability to make independent decisions for the Equipment room.
- Fit sports protective equipment, such as helmets, shoulder pads, shoes and all protective equipment for maximum effectiveness.
- Assignment and recovery of apparel and equipment from team members and coaches.
- Laundry services for the team(s). This includes the retrieval of soiled laundry, cleaning and returning the laundry back to the team and coaches on a daily basis.
- Attend all practices and off season workouts as required.
- Weekly maintenance of equipment including helmets, shoulder pads, shoes and uniforms.
- Travel with the assigned sports team to all road games and will attend all home games. This will include preseason or post season games.
- Pack and move equipment over the road to ensure that equipment and apparel arrive safely and in a timely manner for coaches and athletes use.
- Preparation of the locker room for the teams while they travel and home games.
- Work with the Head Coach on placing orders for the team and coaches.
- Assist coaching staff with the recruitment of student athletes by displaying equipment and making presentations to perspective athletes and parents.
- Attend all staff meetings as required.
- Record and keep records on computerized program for Inventory control.
- Participate in annual Inventory of the equipment room.
- Other duties as assigned by the Senior Associate Athletics Director.

Required Education, Experience, Knowledge, Skills and Abilities:

- Bachelor's degree from an accredited four-year institution
- Minimum of five years full-time experience in the management of an athletic equipment room at the Division One level which includes at least two years of supervisory responsibility
- Current Member of the Athletic Equipment Managers Association
- Experience in the effective instruction, assignment and supervision of subordinates
- Experience working with computerized Inventory program
- Possession of, or ability to obtain, an American Red Cross First Aid Certificate within the first six months of employment
