Overview:

The Assistant Director of Compliance reports to the Assistant Athletic Director of Compliance Services and oversees all facets of NCAA Bylaws 13 (Recruiting), 14 (Eligibility), & 12 (Amateurism).

Primary Duties:

- Monitor all facets of NCAA bylaw 14 (Eligibility)
- Monitor NCAA initial eligibility requirements; produce incoming freshmen report
- Serve as the primary contact with NCAA Eligibility Center
- Conduct compliance student-athlete eligibility meetings in the fall and spring
- Monitor transfer eligibility; produce incoming transfer report
- Provide daily eligibility report to coaches and support staff
- Monitor all facets of NCAA bylaw 13 (Recruiting)
- Approve and monitor official visits and unofficial visits
- Audit phone calls, text messages, and emails
- Approve recruiting travel
- Approve and monitor Institutional Camps & Clinics
- Monitor tryout process
- Monitor participation reports and seasons of eligibility used
- Send and complete tracer forms and permission to contact
- Monitor all facets of NCAA bylaw 12 (Amateurism)
- Provide NCAA rules education
- Supervise Compliance Graduate Assistant
- Other duties as assigned by the Assistant Athletic Director of Compliance Services

- Provide NCAA Rules Interpretations
- Process NCAA violations, NCAA waivers, and Student-Athlete Reinstatements
- Medical Hardships
