## **7th Annual Music Scholarship in Memory of Loretta Ann Price 2010-2011**

Guidelines for Music Scholarship in memory of Loretta Ann Price to benefit a qualified undergraduate (junior year) and a graduating student pursuing a degree in music under the auspices of the California State University, Fresno, School of Arts and Humanities.

1. One scholarship for an undergraduate student pursuing a degree and future career in music, who shall demonstrate financial need and overall scholastic excellence and musical achievement. The committee may choose two students (but no more than two) to share this award.
2. One scholarship for an outstanding graduating student who is receiving an undergraduate degree in music and who intends to teach music in the public schools.
3. Criteria for eligibility are:
  - a. The student must be pursuing a music degree as a full-time undergraduate student.
  - b. The student must have a cumulative minimum GPA of 3.0.
  - c. The student must meet all of the general eligibility requirements established by the Financial Aid Office at California State University, Fresno.
  - d. The applicant must provide a narrative statement that includes educational and professional career goals.
  - e. The application must include a nomination letter from a member of the Fresno-State music department.
  - f. The application must include a resume and a transcript that includes academic courses with grades.
  - g. The student awarded this scholarship must submit a letter of acceptance and thanks to the donor in a timely fashion. Thereupon the student(s) will be designated a LORETTA ANN PRICE Student Scholar; will be announced during the music department convocation during the Fall 2010 and may be announced as such at a College of Arts and Humanities ceremony; and upon showing proof of Fresno State registration shall be awarded from the account, payable in two (2) equal installments on or before September 1, 2010 and February 1, 2011, a sum determined in the discretion of the Fresno State Office of Financial Aid in consultation with the Foundation, provided that such sum, when combined with other Loretta Ann Price scholarship awards, shall not exceed the account balance. The foundation may, in its discretion, pay sums awarded here on behalf of/for the account of the student, rather than director to or to the order of the student.
  - h. Any monies so awarded constitute an unconditional recognition of an established record of scholastic merit and student excellence.
  - i. This scholarship specifies that full-time student status in good standing shall at all times be a pre-requisite to eligibility to receive financial assistance hereunder.
  - j. In the event an award recipient becomes ineligible to receive the award for any reason including without limitation a change of major or a loss of full-time student status in good standing, such recipient shall immediately return any monies remaining on hand and shall be disqualified from receiving/shall forfeit any further assistance hereunder. Whereupon any such returned and forfeited monies may be awarded to another student in the manner specified by the criteria as stated above.

4. Deadline for application is February 26, 2010. All materials (application, nomination letter, GPA, and performance/academic resume) must be received in the department of music office by deadline.
5. All applicants will be notified of the results no later than eight weeks after the application deadline; or contacted by a Scholarship Committee Member.
