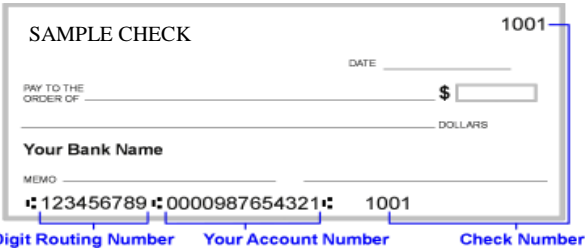

AEI PAYMENT INFORMATION

The AEI is unable to accept credit card payments for the application fee. If you are outside the United States, your check for any AEI costs should include a computerized routing number, account number, and check number, which is payable through a U.S. bank in U.S. dollars.

Payment of all costs on registration day can be made with traveler's checks, an international check, a personal check drawn on a U.S. bank, or a personal credit card (Visa or Master Card only). **All amounts paid are non-refundable.**

HEALTH INSURANCE INFORMATION

The AEI group insurance coverage is required for all students with an F-1 visa. Coverage will begin on or before the first day of class. The AEI recommends that you view the U.S. Healthcare System video at www.internationalstudentinsurance.com before you come to the United States.

SEVIS I-901 FEE

All new AEI students with I-20s marked for "initial attendance" are required to complete Form I-901 and pay a SEVIS fee before making an appointment to obtain a student (F-1) visa. This fee is not payable to the AEI. Payment of the SEVIS fee does not guarantee that you will be issued a student visa.
