

REGISTRATION & FEE PAYMENT

All participants in this program must register for credit, including non-matriculated individuals.

Course fee is \$4,370. The initial payment of \$2,185 is due to the Division of Continuing and Global Education by September 16, 2016 and the balance payment of \$2,185 is due October 20, 2016.

It is important to understand that you are undertaking a serious contractual obligation when you register for your travel study program. Starting on September 16, 2016, you are responsible for all your travel study program fees of \$4,370, which will be posted to your account even if you withdraw from the program.

Note: all fees are subject to change.

CGE REFUND SCHEDULE

You may withdraw from the program at any time, and you will be eligible for a full refund of your CGE paid fees if you withdraw before September 16, 2016. Beginning September 16, 2016, no refunds will be made. If you withdraw from the program on or after September 16, 2016, the university will place a hold on your student account and require you to pay the full amount of fees for the travel study program. Further, you will be unable to register in future Fresno State classes until this financial obligation is paid in full.

THE PROGRAM

Participants will visit Chile's agricultural field and food production sites to learn about the different production practices that are used. Students will observe during the site visits how products are tested, harvested, cooled, stored, transported, branded, inspected, traded and so forth. Participants will tour food facilities to learn how food products are prepared for final domestic and export markets. One visit will include a briefing from the US Embassy Agricultural Attache as well as a tour of the port where the USDA inspects food products destined for the US market.

Early registration is strongly encouraged. Proof of a valid passport is required prior to the trip. Any disability requiring special attention must be reported to the instructor.
