General Criteria: See Scholarship Checklist

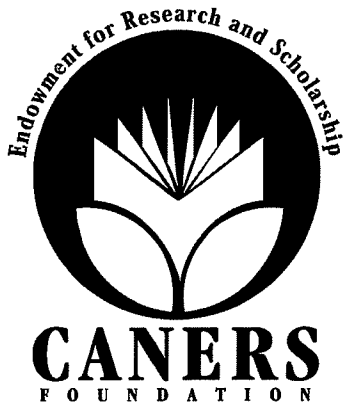
1. Student must be currently enrolled in 6 units within a nursery-related program.
2. Legibility is critical (12-point type preferred but no smaller than 10 pt. - No unusual fonts).
3. Grades are important, but a B student who participates in horticulture related activities may be selected over the A student who does not participate in FFA, 4-H, or other related activities.
4. Current school year letters of recommendation are important. Sources to contact for these letters are noted on the application. Email letters of recommendation are not accepted.
5. Current transcripts need to be included with the application. Please make sure your students understand that computer-generated transcripts (not printed by the school's admissions office) must be signed by the horticulture instructor.
6. Applications postmarked after March 15, 2015 will not be considered.

## What makes your application complete?

❖ **BEFORE FILLING OUT ALL OF THE FORMS...college students, ask yourself this question:**

Does your major qualify for a CANERS Scholarship? **Majors NOT accepted:** Landscape Architecture, Dairy Science, Enology/Wine, Floral Design, Golf/Sports Turf Management, Animal Science, and Landscape Contractor.

❖ **COLLEGE STUDENTS...No fewer than six units.** This scholarship application must be used by college students who are currently enrolled in **no fewer than six units** within an approved program related to the nursery industry, and who are entering or returning to college in a horticulture related field in the fall or spring.

❖ **HIGH SCHOOL SENIORS:** Current high school seniors that are entering college in a horticulture-related field in fall 2015 are eligible for a CANERS Scholarship.

❖ **AT MINIMUM...Two Current Reference Letters are required.**

❖ **MANDATORY...Submit Transcripts.**

Careful! It may take up to 4 to 6 weeks to obtain transcripts. The transcripts must be dated by the application **March 15, 2015**. Read the transcript portion of instructions carefully. As an example, the horticulture instructor must sign all facility and student computer generated transcripts for current class schedule.

❖ **DON'T BE LATE March 15, 2015 is the application deadline.**

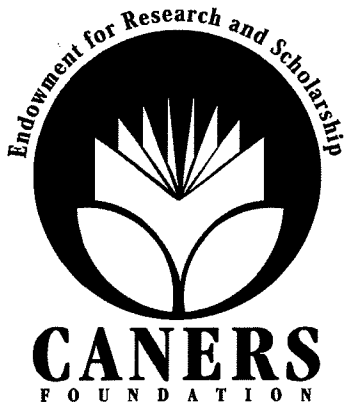

### FOR A SUCCESSFUL APPLICATION, PLEASE FOLLOW THESE INSTRUCTIONS...

1. This application must be used by college students who are currently enrolled in **no fewer than 6 units** within a program related to the nursery industry, and who are entering or returning to college in a horticulture related field in the fall or spring.
2. **SUBMIT** all college and university transcripts from the previous five years including classes in progress (copies acceptable for current study list only).
  - a. The horticulture instructor must sign all facility student computer generated transcripts.
  - b. Important: The last school semester or quarter completed must be on the transcript.
3. Applications must be typed or printed legibly (12 pt. type preferred, but no smaller than 10 pt; no unusual fonts).
4. **REFERENCE LETTERS MANDATORY** At Minimum Two Letters Required
  - a. Current school year personal reference letters, signed and dated, should be attached and sent in with this application.
  - b. Reference letters can be from your most recent employer, horticulture instructor, FFA or ROP leaders, counselor, club/activity advisor or church leader are very helpful in assisting the committee in their selection of recipients.
  - c. It is highly recommended that you include one letter from **your horticulture instructor**.
  - d. Email letters are not acceptable
5. Completed application forms, transcripts and letters of recommendation must be returned to the California Association of Nurseries and Garden Centers office, 1521 I Street, Sacramento, CA 95814, and **POSTMARKED NO LATER THAN March 15, 2015.**
6. Winners will be announced by June 21, 2015, and scholarships awarded as deemed by the Scholarship Committee of the California Association of Nurseries and Garden Centers. No scholarship will be issued until the institution verifies that the recipient is enrolled in and attending six or more units within a nursery industry program.
7. **Majors NOT accepted:** Landscape Architecture, Dairy Science, Enology, Floral Design, Golf/Sports Turf Management, Animal Science, Landscape Contractor.
8. **INCOMPLETE APPLICATIONS WILL NOT BE CONSIDERED. DO NOT FORGET TO SIGN THE APPLICATION.**
