Position Summary: The Kremen School of Education and Human Development (KSOEHD) at California State University, Fresno seeks applicants for a tenure-track, academic year position as an Assistant Professor in Research and Statistics in the Department of Curriculum and Instruction. Responsibilities include teaching graduate research courses, mentoring graduate students in a variety of master's and doctoral degree programs, conducting scholarly and applied research, and engaging in service-related activities within the university and community. Teaching assignments and research interests will be in the area of research, statistics, measurement and program evaluation.

Overview: The Kremen School of Education and Human Development's (KSOEHD) mission is the recruitment and development of ethically informed leaders for classroom teaching, educational administration, counseling, higher education and other educational professionals. This NCATE-accredited unit fosters the candidate dispositions of collaboration, valuing diversity, critical thinking, ethical judgments, reflection, and life-long learning. Our mission is realized through a framework of teaching, scholarship, and service that addresses regional, state, national, and international perspectives. The KSOEHD has four Departments offering master's degrees in counseling, curriculum and instruction, early childhood education, educational leadership, multilingual/multicultural education, reading, rehabilitation counseling, special education, and teaching. A doctoral program in educational leadership is also offered. Research faculty members are housed in the Department of Curriculum and Instruction and teach research, statistics, evaluation and measurement courses to graduate students in all departments and programs. Research faculty members are known for excellence in teaching, procuring/evaluating grants, and providing research support to faculty in the school and university. Opportunities to engage in research and program evaluation projects through the Center for Research Evaluation and Development (CREAD) are available.

Required Education: An earned doctorate (Ph.D. or Ed.D.) in Research Methodology, Statistics, Measurement, Program Evaluation, Educational Psychology, Education, or other closely-related disciplines from an accredited institution (or equivalent) is required; however, applicants nearing completion of the doctorate (ABD) may be considered. For continued employment in the tenure-track position the doctorate must be completed by 8/12/2016.

Required Experience: The successful candidate must have 1) extensive coursework in the areas of research, statistics, measurement and/or evaluation, and 2) ability to demonstrate a commitment to working effectively with faculty, staff, and students from diverse ethnic, cultural, and socioeconomic backgrounds.

Preferred Qualifications: 1) Successful teaching experience at the graduate, undergraduate or K-12 level; 2) expertise in educational measurement, and; 3) secondary area(s) of expertise such as program evaluation, English language learners, curriculum, teacher training, counseling, educational administration, and technology; 4) evidence of successful research activities, such as publications in scholarly journals, funded grant proposals, evaluation work and/or collaborative research.

Application Procedures: Review of applications will begin November 20, 2014, and will continue until the position is filled.
