Introducing the First Three Doctoral Cohorts of the New Doctoral Program in Educational Leadership at Fresno State (DPELFS)

In April 2007, Fresno State was the first California State University campus to receive final approval from Chancellor Charles B. Reed to offer a doctorate in educational leadership. A change in state law permitted independent doctoral programs in educational leadership to be offered at California State University campuses. The new program offers separate tracks for Pre-K-12 and post-secondary (community college and higher education institutions) education leaders.
