Student very clearly explains one democratic institution and how it contributes to representative government. Student very clearly identifies and discusses one American U.S. ideal. In order to be deemed advanced, the student must give four or more detailed examples and clearly differentiate between earlier and later time periods."

3-proficient - "Student clearly explains one specific aspect of the Constitution. Student identifies one American/U.S. institution and clearly explains the connection to representative government. In order to be deemed proficient the student must give a minimum of three specific examples that relate to U.S. documents and institutions described and must refer and clearly differentiate between an earlier and later time periods."

GE Area D1 Outcome 2 Rubric: Modifications were made to replace "American" with "U.S."

Other Modifications:

4-advanced - "Student very clearly explains the origin of one U.S. American social AND/OR cultural institution. Student very clearly explains the origin of one U.S. American economic institution. Student very clearly explains the origin of one U.S. American political institution. In order to be deemed advanced the student must provide detailed examples of all institutions listed and give an in-depth description of how each of the three have changed over time."

3-proficient - "Student explains the origin of one U.S. American social AND/OR cultural institution. Student explains the origin of one U.S. American economic institution. Student explains the origin of one U.S. American political institution. In order to be deemed proficient, the student must give an example for each institution listed and includes some details that is detailed enough to be clear. The student must also clearly indicate one change that occurred in each of the three institutions."
