

# EARLY EDUCATION AND CHILD CARE SERVICES

Fresno State Programs for Children includes three centers:

The Campus Children's Infant/Toddler Center,  
The Campus Children's Preschool Center, and  
The Joyce M. Huggins Early Education Center

The centers provide services for children between the ages of 3 months and 12 years. The program works in partnership with Fresno State and the larger community to provide opportunities for learning and for developing partnerships that will benefit young children and families.

Fresno State Programs for Children, Inc. provides services to the children of the California State University, Fresno **student body** and to a **limited extent, faculty, staff, and the larger community.**

The programs are designed to meet the unique needs of each child in order to help them build fundamental skills, develop critical social relationships, and acquire a valuable education that will help put them ahead in all aspects of their lives.

The three programs offered are:

- Infant-Toddler (3 months-2 years)
- Preschool (3 years - 6 years)
- School Age (5 years - 12 years)

# EARLY EDUCATION AND CHILD CARE SERVICES

## INFANT/TODDLER PROGRAM

To support the unique needs of infants and toddlers, teachers are responsive to infants' and toddlers' individual nonverbal cues and provide immediate physical comfort and needed care. Teacher's interactions should be based on the child's temperament and level of arousal. Caregiving routines are used as an opportunity to build a one-to-one relationship with each child. Social interactions with teachers should be ongoing and include verbal and nonverbal face-to-face communication.

Infant/ Toddler Program Operating Days/Hours:

- **7:30 a.m. - 5:30 p.m**
- Center hours may vary during the summer months

## PRESCHOOL PROGRAM

Children attending kindergarten enroll with the preschool classroom during the school year. During the summer, they are enrolled with the School Age Program.

Preschool Program Operating Days/Hours:

- Open **5** days a week from **7:30 a.m. - 5:30 p.m.**
- An Extended Day Program is available from **5:30 p.m. - 6:00 p.m.**
- Center hours may vary during the summer months.

## SCHOOL AGE PROGRAM

Children attending kindergarten enroll with the preschool classroom during the school year; during the summer, they are enrolled with the School Age Program.

School Age Operating Days/Hours:

- Summer Availability from **6:45 a.m. to 5:30 p.m.** Monday through Friday.
- An Extended Day Program is available from 5:30 p.m. - 6:00 p.m. for **kindergarten-aged** children.
- Limited positions available for care between **5:30 p.m. - 6:00 p.m.** for kindergarten-aged children during the school year
- Center hours may vary during the summer months.

# EARLY EDUCATION AND CHILD CARE SERVICES

## ELIGIBILITY

Fresno State Programs for Children, Inc. provides services to the children of the California State University, Fresno student body and to a limited extent, faculty, staff, and the larger community. We are a funded program of the California Department of Education (CDE). We are mandated by CDE to follow state admission priorities. Fees for low-income families are determined on a sliding scale based on family size and income. The scale is provided by the State Department of Education. Families paying full fee are enrolled if space is available.

It is our goal to serve as many California State University, Fresno student families as possible while providing high quality care and education services for children enrolled in the program. Enrollment priorities are determined by a waiting list. Individual families may apply for services at any time during the year, but must renew their application each March. Applications that are not renewed for the upcoming academic year are placed in an inactive file and taken off the waiting list.

## WAITING LIST PRIORITY

### 1.

1. Currently enrolled returning families and siblings, if eligible.
2. New applications from families who are eligible for subsidized services in order of the highest ranking using ranking criteria established by the State Department of Education. After enrollment of all eligible student families (both returning and new) consideration is next given to--

### 2.

1. Student families receiving subsidies from other sources (e.g. Supportive Services, PACE, Fresno County, DSS).
2. Student families willing and able to pay the full fee.

### 3.

After student families have been enrolled, consideration is then given to:

1. California State University, Fresno faculty and staff.
2. Community members
