 - ⇒ Your parent(s) will provide more than half of their support from July 1, 2016 through June 30, 2017, **OR**
 - ⇒ the children would be required to provide parental information when completing a 2016-2017 FAFSA
- other people currently living with your parent(s) for whom **your parent(s) currently provides and will continue to provide at least 50% of their support** from July 1, 2016 through June 30, 2017.

Do not include the following:
