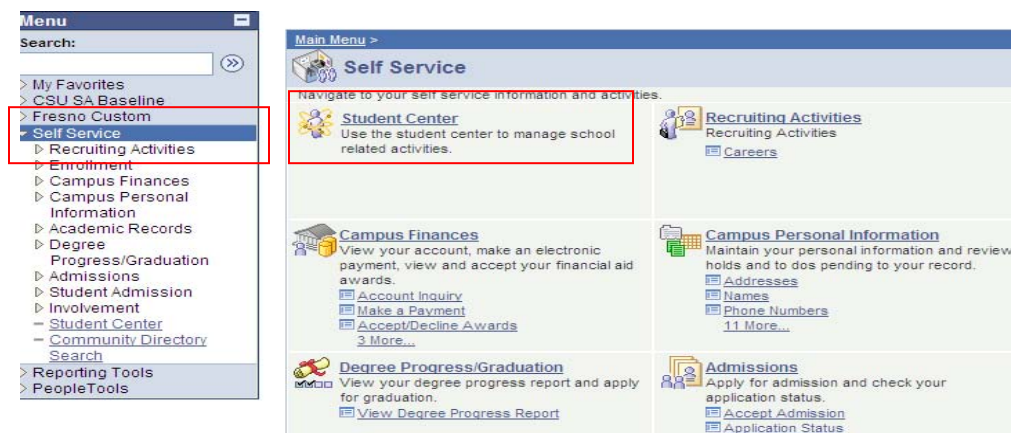

- 3) Completed all financial aid To Do requests for forms or actions
- 4) Enrolled for the equivalent of 6 or more units

Please Note! **All borrowers** at California State University, Fresno are required to complete an [Entrance Counseling Session](#) and sign a [Master Promissory Note](#) (MPN) to receive their funds. You will need to have your FAFSA "PIN" number available to finalize the process electronically.
