The following information is required to continue processing your student's 2012-2013 financial aid application. In order for us to verify your 2011 income and wage information, you must provide information requested below. We strongly encourage you to utilize the IRS Data Retrieval functionality on the FAFSA- either in the initial filing of the FAFSA, or by submitting a correction at [www.fafsa.gov](http://www.fafsa.gov)

**PLEASE NOTE:** Copies of Tax Returns are no longer valid forms of income verification. If you were unable to use the IRS Data Retrieval function on the FAFSA, you **MUST** obtain a **2011 Tax Transcript** from the IRS to submit to our office. Transcripts must be requested by the tax filer directly from the IRS either online at [www.irs.gov](http://www.irs.gov) or by calling 1-800-908-9946. It can take up to 10 days for the IRS to process the request. Make sure you **do not** order an "Account Transcript" as this will not provide all the information needed.
