ROYALTY WAIVER REQUEST FORM

For Products for Internal Use by Campus Departments and University Recognized Clubs and Organizations

Departments and university recognized clubs and organizations are required to seek prior approval when ordering any products bearing any university trademarks (i.e. names, marks, logos and/or symbols) for commercial venture, whether fund raising or promotional. Products purchased by a department, club or organization for internal use are exempt from royalty fees typically applied to products for resale or promotional use. All products bearing university trademarks **MUST** be produced by and purchased from a vendor licensed by the university through the Collegiate Licensing Company. Products purchased by or on behalf of a department, club or organization which are to be resold or given away as a promotional item, **ARE NOT EXEMPT** from royalties. Before ordering any product bearing any university trademarks, approval must be granted by the Office of Trademark Licensing. The following waiver must be completed and signed by the appropriate representative(s) prior to production. **ITEMS NOT APPROVED FOR ROYALTY EXEMPTION MAY STILL BE PRODUCED WITH ROYL TIES APPLIED**.
