MSC to send a memorandum to Student Affairs asking them to post the Harassment Policy everywhere they have the Code Governing Student Conduct, stating that a violation of the Code Governing Student Conduct is a violation of the Harassment Policy.

MSC to approve as amended the Policies and Procedures for Addressing Harassment and forward to the President for his approval.
